Notes

The charges set out in this schedule for cleaning, drying and other treatment of grain and screenings shall be computed, in the case of grain, on the accountable gross weight of the grain, or in the case of screenings, on the weight of the screenings.

The charges set out in this schedule for the elevation and storage of screenings shall be computed on the weight of the screenings, and the charges set out in this schedule for the elevation and storage of grain shall be computed on the net weight of the grain, except where the grain is handled on a gross weight basis, in which case the charges shall be computed on the accountable gross weight of the grain.

Other Services – CONT'D

Services
For all other services published in the Canadian Grain Regulations maximum tariffs shall apply as per appropriate schedule, as, or if, amended.
For services not published in the Canadian Grain Regulations, charges shall be made by arrangement.
a) The charges for cleaning, drying and other treatment of grain and screenings set out in this Schedule shall be computed on the accountable gross weight of the grain, or in the case of screenings, on the weight of the screenings.
b) The charges for elevation and storage set out in this Schedule shall be computed on the weight of the screenings and the charges for elevation and storage of grain set out in this Scheduled shall be computed on the net weight of the grain except where the grain is handled on a gross weight basis, the charges shall then be computed on the accountable gross weight of the grain.

Note: A \$300 surcharge will apply to all tug requirements on Statutory Holidays, as well as those that are outside the hours of 8:00 am – 4:00 pm Monday to Friday

Tugs must be ordered 12 hours in advance. If ordered less than 12 hours in advance, tug service may not be available.

Cancellation with two hours or less notice in advance of appointed time, will result in a half service charge.

Cancellation after tugs have mobilized will result in full service charges.

Vessels arriving more than 30 minutes later than the appointed time at the pilot boarding station, will be assessed standby charges on a half hour basis.

*** Tug services for all movements is compulsory.**
